



How to File Your Room Tax

Once you have signed into your permit profile, click the “Online Filing” button at the top of the profile page. Under the Lodging Establishment section, select the report month and year from the dropdown options.

In line 1, enter the total number of unit nights your rental was available for the month.

Helpful Hint: If you had one rental unit (ex. one house) available every day in March, your total available rental units would be 31, if you had two units, it would be 62.

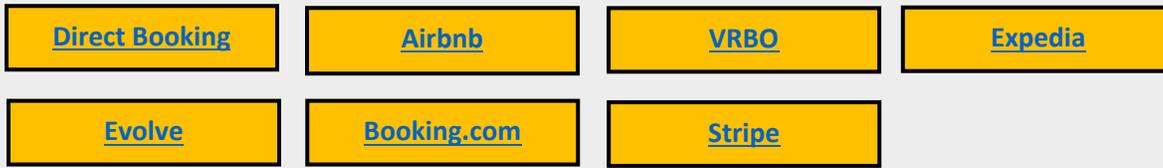

Line 3 and line 5 entries will depend on which booking platforms are used for your property. Please click below to find individual instructions based on your marketing platforms.



In line 3, enter your total sales for the month, including all applicable taxable fees (ex. cleaning fees and pet fees).

In line 4, enter any exempt sales.

Helpful Hint: most permit holders will rarely have exempt sales. Sales qualify as exempt under the following conditions most often: if a guest stayed 30 or more nights in a row or the guest is able to provide proof of tax exemption (a CES number), the stay is exempt from short-term rental tax and the sales amount can be added into line 4. Please be advised that the Tourism Zone reserves the right to request copies of documentation proving exemption.

In line 5, enter any sales made through marketplace provider platforms in which tax was collected and remitted on your behalf, which was found when calculating line 3.

In lines 5a-5e, enter 8% of the sales made through marketplace provider platforms into the corresponding line. For any marketplace providers you do not use, simply enter zero.

If you do not use any marketplace providers, put zeroes in all line 5 sections.

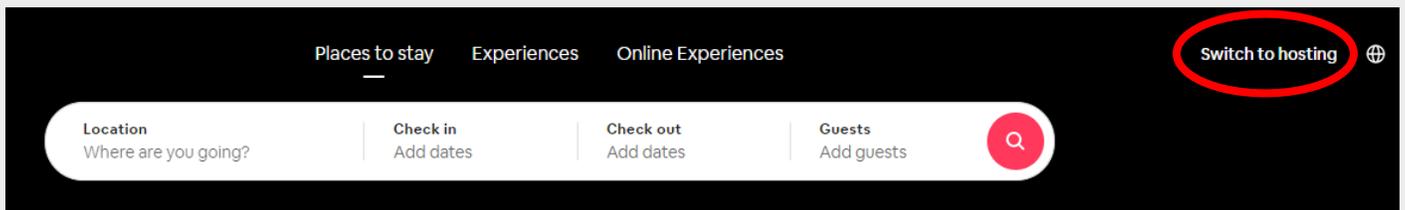
In line 3, add the total amount of taxable lodging sales for the month. This must include taxable fees like cleaning fees or pet fees, if applicable.

In line 5, enter zero if you do not use any marketplace provider platforms. If you do use other platforms, add your direct sales to line 3 in addition to the sales totals from your marketplace platforms.

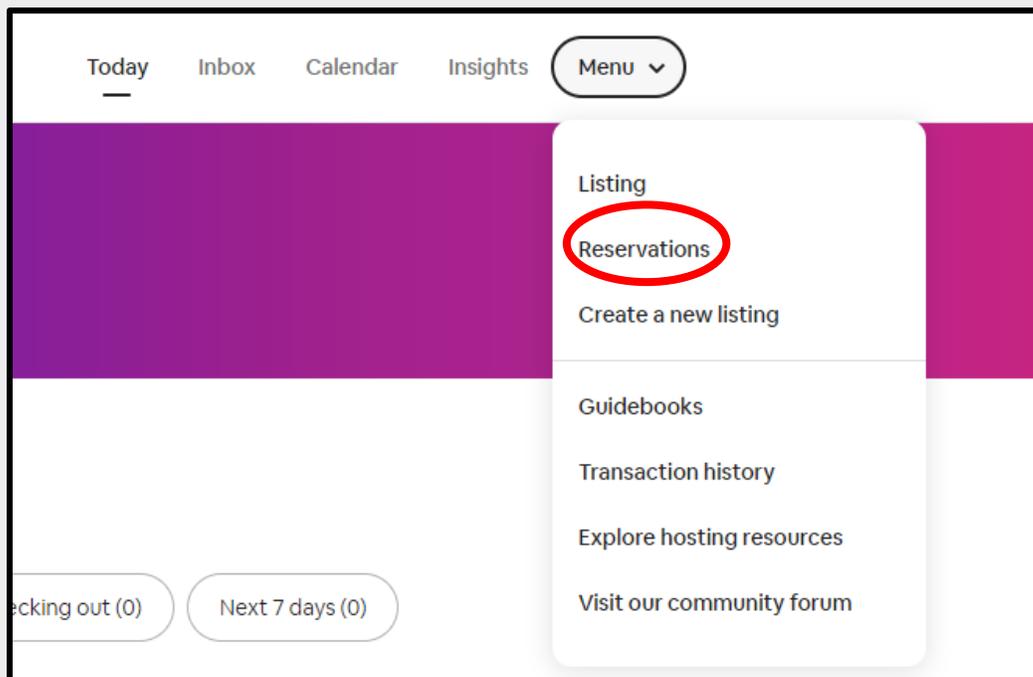

Airbnb

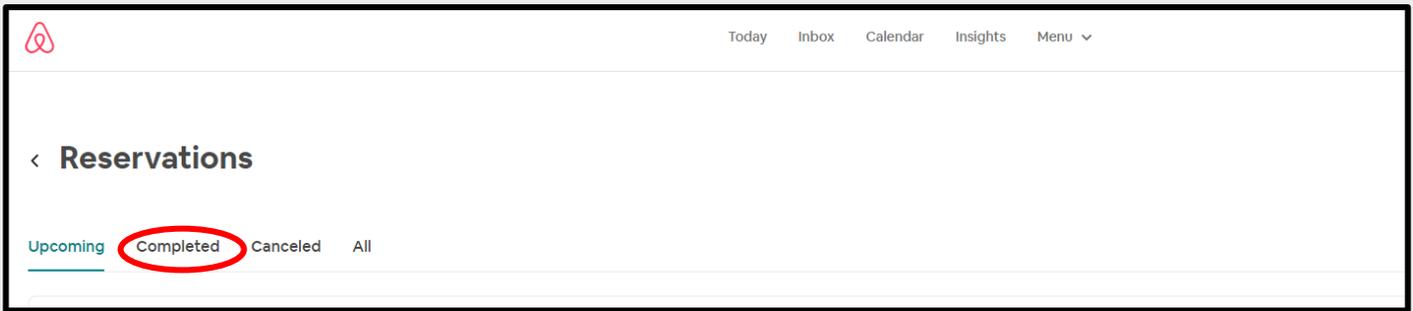
Sign into your Airbnb account. Make sure you are using a hosting profile.



Click “Menu” at the top middle bar and then click on “Reservations.”



Click “Completed” under Reservations.



Under “Completed” you will see a list of your check-in dates. Make sure you are only focusing on the stays taking place in the month you are reporting on. Click “Details” in the blue box to the right of your screen. This will create a popup screen showing a guest payment breakdown.

Add together the nightly rate x number of nights, cleaning fee, and the guest service fee (Ex. $\$1635 + \$300 + 273.18 = \$2208.18$). This total will be the booking’s Airbnb lodging sales. Go through each booking for the reporting month and follow the same process.

Multiply your total sales x 13.5% to verify the correct amount of tax was collected (Ex. $2208.18 \times 13.5\% = \298.1). However, if your rental falls within the boundaries of Sister Bay or Ephraim, the total tax will be 14.0%.

If Airbnb, is the only platform used to book your property, the sum of all Airbnb lodging sales found in the previous step will be written into lines 3 and 5. If you use other platforms, add the total sales to lines 3 and 5 and continue adding you other sales. If you would like to return to the main instructions page, [click here](#).

Sign in to VRBO and make sure you are using your hosting profile.

Click on “Calendar” and select which month you will be reporting for, then select the first booking for the month on the bookings and blocks list.

Add together the Booking amount and Traveler service fee. Multiply your total sales x 13.5% to verify the correct amount of tax was collected (Ex. 3413.25 x 13.5%=\$460.79). However, if your rental falls within the boundaries of Sister Bay or Ephraim, the total tax will be 14.0%.

$$\$3047.25 + \$366.00 = \$3413.25$$

The booking amount plus the traveler service fee will be your total gross sales for the month if you only book through VRBO. If this is the case, put this number in line 3 and line 5 on your report form as the gross lodging sales. Expedia

If Expedia is the only platform used to book your property, the sum of all Expedia lodging sales will be written into lines 3 and 5. Multiply your total sales x 13.5% to verify the correct amount of tax was collected (Ex. 3413.25 x 13.5%=\$460.79). However, if your rental falls within the boundaries of Sister Bay or Ephraim, the total tax will be 14.0%. Evolve

Many Evolve users also use Avalara, which remits taxes using the Evolve platform on behalf of the permit holder. For Avalara users who use Evolve, the sales can be added to line 3 and 5 with the taxes remitted being entered into line 5e. If you use Evolve and are not an Avalara user, contact the Tourism Zone at info@doorcountytourismzone.com to verify whether taxes have been remitted on your behalf or whether they will need to be entered as direct sales.

Booking.com

Booking.com does not remit taxes to the Door County Tourism Zone on behalf of lodging providers. Sales and taxes that have gone through Booking.com will need to be entered as direct bookings in line 3 only.

Stripe

Stripe has several available programs, some of which include tax collection and remittance, some of which do not. Most stripe users will need to collect and remit their own tax, in which case all lodging sales on the platform will need to be entered as direct bookings.
